In particular the area, reference no 79066 Pitt St, reserve, and Caravan Park, where SCG members overwhelmingly voted for the need for showers and taps at Little Beach. # 6.2 Stockton Beach inclusive of Newcastle CMP

Ron Boyd provided the following information

- Port of Newcastle have submitted a new Sea Dumping Permit application to Australian Department of Environment for dredging and dumping from Newcastle harbour.
- Other stakeholders including Stockton Community Group, City of Newcastle, NCCDC, and DPIE also made submissions. Application and submissions were sent for external technical review.
- On the basis of review, the permit application was not approved, and PoN were requested to provide additional justification and technical information.

# 6.3 Air Quality & Environment - Ammonium Nitrate Storage Kooragang Island/NCCCE

Recorded atmospheric sulphur levels have decreased due to ships using lower sulphur fuel.

PM 2.5 (the smallest particle size) ammonium nitrate emissions has been addressed by Orica and they will be installing new filters on the prill tower. This will significantly reduce these emissions.

Cleanliness and pigeon droppings in Stockton IGA arcade and flooding of car park are being investigated by Jeremy Bath (CEO of Council). Will be followed up by SCG in meeting with Lord Mayor in March.

#### 6.5 Stockton Community Liaison Group

- At the last SCLG meeting on 9 December, our Stockton representatives again stressed the
  importance of ensuring the negative impact of the Breakwaters and PoN dredging on
  Stockton beach would feature in the 2022 CMP; this was taken up by CN as an Action
  Point. CN was also asked to provide a more detailed response to the SCLG regarding the
  triggers for sand scraping. A further request for this information had been made to Philippa
  Hill that day.
- The Deputy Premier visited Stockton beach recently with the Lord Mayor Nuatali Nelmes,
  Deputy Lord Mayor (and new Ward 1 Councillor) Declan Clausen and State MP Tim
  Crakanthorp following urgent requests for his continuation of the Stockton Beach Taskforce.
  He was shocked by the state of the beach and supportive of the proposed action but at this
  stage has not actually offered the "big bucks" needed for beach restoration.
- Councillor Clausen and Federal MP Sharon Claydon have recently been discussing the role that the Commonwealth can play in sand acquisition for Stockton. Sharon Claydon had already been keeping the relevant Government Minister informed over the past few years.

- 1) Willow Forsyth's comments on Coastal Inundation Assessment by Bluecoast Consulting Engineers. More information can be provided on request.
- Hazard assessment model outputs included estimates of depth but not velocity of waves inundating Stockton from storm surge overtopping events. It is incomplete without velocity as the speed of the wave is critical for estimating potential damage and thus exposure risk.
- The model uses an assumption of "significant wave height" being the estimated 40% biggest waves. However, if the biggest wave is 2x that, then the damage from that may be disastrous. Why not estimate the biggest wave from each major class of events.
- The model outputs were only for 1% AEP (1 in 100 ARI) events. If a big wave in a 2% (1 in 50 ARI) event can cause significant damage, isn't that important to know. What is the most frequent event where the biggest wave is expected to inundate Stockton and to what depth and with what velocity (speed and force).

Question from audience: Is there an emergency plan for Stockton in case of a Tsunami? Reply: SES website provides best advice on how to be prepared for tsunami and more information can be found on City of Newcastle Flood Emergency Sub Plan on SES website. Also BOM will have warnings for tsunami.

2) Inquiry as to why toilet blocks are closed so early, as public areas are still in high use by community until 9pm. To be followed up with council.
