Alicia provided an overview of waste management and recycling activities by City of Newcastle, partner companies, and state-wide targets and initiatives. CN is licensed by the EPA for waste management.

Primary aim is to reduce land fill. CN has land fill capacity for approx. 30 years, with neighbouring councils already nearing capacity.

CN have a number of strategies to support household waste management and reduce landfill including:

5.2 Stockton Beach Group (Alison Rigby)

 SCG Inc has submitted a response to the Draft Extended Stockton Coastal Management Program document. Key issues related to lack of clear agency accountability, budget allocations and timeframes. Concerns re lack of CN consultation opportunity for Stockton residents also raised.

5.3 Air Quality & Environment (Keith Craig)

- The new Orica scrubber system is performing to expectation for improved air quality and particle release.
- Odours from the canola oil plant on Kooragang have been noted. The plant's odour is mitigated with the regular replacement of a biological bed. Increase in odour should be reported to the EPA to ensure the company is held to account for timely replacement of the biological bed.

5.4 Community and Crown Land (Carolyn Bailey)

- Correspondence to CN and Councillors requesting update on work to improve public toilets at the Activity Hub/ferry and community consultation process.
